Automatic Entry to Honours

Students who attain an average of grade 11.0 or above at the first sitting in the requisite 2000-level modules and who meet all other programme requirements will be given automatic offers of entry into Honours programmes.

Students permitted automatic entry to Honours will only be permitted to trail one module to a maximum of 30 sub-honours credits into Honours.

BSc / MA Honours

The general requirements are 480 credits over a period of normally four years (and not more than five years) or part-time equivalent, of which the final two years form an approved Honours programme of 240 credits, of which 90 credits are at 4000 level and at least a further 120 credits at 3000 and/or 4000 levels.

BSc / MA Honours with Integrated Year Abroad

The general requirements are 540 credits over a period of normally five years (and not more than six years) or part-time equivalent, of which the final three years are an approved Honours programme of 300 credits, of which 60 credits are gained during the integrated year abroad, 90 credits are at 4000 level and at least a further 120 credits at 3000 and/or 4000 levels.

Study Abroad: In the case of students who spend part of the Honours programme on a recognised Study Abroad scheme, the Programme Requirements will be amended to take into account overseas courses which are approved by the

There has been a significant curriculum overhaul affecting modules delivered from 2015/6 onwards.
These programme requirements reflect the changes.

Applied Economics - Single Honours BSc or MA

For those entering first year in 2015/6

First Year: (60 credits: EC1001, EC1002 and EC1003 (*Students who have passed MT1002 are exempt from EC1003*).

Second Year: 40 credits: EC2001 **and** EC2002 - with passes at first sitting and an average grade of 11 or better across both;
20 credits: EC2203
(*Students who have passed MT2004 or MT2508 are exempted from EC2203.*)

Third Year: 20 credits: EC3301;
100 credits: EC3302 - EC3350, EC4401 - EC4489 OR from selected MN and IR modules approved by the Head of School of Economics & Finance AND the other School.

Fourth Year: 120 credits: EC3302 - EC3350, EC4401 - EC4499, selected MN and IR modules approved by the Head of School of Economics & Finance AND the other School.

Students must take at least 40 credits from EC3302 - EC3350, EC4401 over third and fourth year.

Students may take a maximum of 30 credits in MN and IR modules.

In total, at least 90 credits must be achieved at 4000 level.

Economics & Finance - Programme Requirements 2015/1 - August 2015

Applied Economics - Single Honours BSc or MA For those entering second or third year in 2015/6

First Year: 40 credits: EC1001 **and** EC1002.

Second Year: 40 credits: EC2001 **and** EC2002 - with passes at first sitting and an average grade of 11 or better across both;
20 credits: EC2003 **and** EC2004.
(Students who have passed MT2004 or MT2508 are exempted from EC2003; students who have passed MT2503 or MT2001 are exempted from EC2004.)

Third Year: 20 credits: EC3301;
100 credits: EC3302 - EC3350, EC4401 - EC4489, selected MN and IR modules approved by the Head of School of Economics & Finance AND the other School.

Fourth Year: 120 credits: EC3302 - EC3350, EC4401 - EC4499, selected MN and IR modules approved by the Head of School of Economics & Finance AND the other School.

Students must take at least 40 credits from EC3302 - EC3350, EC4401 over third and fourth year.
Students may take a maximum of 30 credits in MN and IR modules.
In total, at least 90 credits must be achieved at 4000 level.

Applied Economics - Single Honours BSc or MA For those entering fourth year in 2015/6

First Year: 40 credits: EC1001 **and** EC1002.

Second Year: 40 credits: EC2001 **and** EC2002 - with passes at first sitting and an average grade of 11 or better across both.
20 credits: EC2003 **and** EC2004.
(Students who have passed MT2004 or MT2508 are exempted from EC2003; students who have passed MT2503 or MT2001 are exempted from EC2004.)

Third Year: 75 credits: EC3201 **and** EC3202 **and** EC3203;
45 credits: EC4500 - EC4509, EC4511 - EC4589, selected MN and IR modules approved by the Head of School of Economics & Finance AND the other School.

Fourth Year: 30 credits: EC4205;
90 credits: EC4203, EC4302, EC4601 – EC4689, selected MN and IR modules approved by the Head of School of Economics & Finance AND the other School.

Students may take a maximum of 30 credits in MN and IR modules.
In total, at least 90 credits must be achieved at 4000 level.

Economics – Single Honours BSc or MA

For those entering first year in 2015/6

First Year: 60 credits: EC1001, EC1002 and EC1003 (*Students who have passed MT1002 are exempt from EC1003*).

Third Year: 20 credits: EC3301;

Fourth Year: 120 credits: EC3302 - EC3350, EC4401 - EC4499.

Students must take at least 40 credits from EC3302 – EC3350, EC4401 over third and fourth year.
In total, at least 90 credits must be achieved at 4000 level.
